This is the EBN we have completed recently.

After submitting this and engaging further with Health, I briefed up in March that Health had advised they would produce a report to us by 25 March outlining their internal review of the threshold questions. As a consequence, the matter was returned to me to progress, as I believe through further engagement we could rectify the issue.

QPS were later advised that Health would not reveal their own review till they received their own legal advice.

We continued our requests. This then led to the commitment of Ms Lara Keller of Health on 30/5 that she was committed to engaging further with QPS to explore the issues, after an email was sent from QPS on 30/5 requiring a change in thresholds.
